Manchester. We fully recognise that our small size and single-subject provision places boundaries on our impact as a higher education provider. However, within our area of specialism, and among our networks of influence, we aim to use our resources strategically to nurture ambition and multiply educational opportunities

The College is committed to widening participation and supporting student success, especially for:

- Ethnic minority groups
- Socio-economically disadvantaged students
- Mature students and students with parental responsibilities
- Students who have a disability

Cliff College has identified key risks to equality of opportunity and is implementing targeted strategies to address these risks across the student lifecycle of access, success, and progression.

Fees we charge

Fees charged for the 2025-26 academic year are:

- £9,000 for full-time undergraduate students
- £4,500 for part-time undergraduate students.

Fees may increase annually in line with inflation, within the tuition fee cap.

Cliff Diversity Scholarship	Ethnic minority students	£1,500 (FT) / £750 (PT) annually
Study Support Bursary	Mature students or carers (meanstested)	£500–£1,000 (FT) / £250– £500 (PT)
Disability Support Bursary	Students with disabilities (means-tested)	£250–£1,000 annually

What we are aiming to achieve

We have set four main objectives for 2025–2029:

- 1. Increase the proportion of students from an ethnic minority background to 18.5%;
- 2. Increase the proportion of part-time undergraduate students from economically disadvantaged backgrounds to 16%;
- 3. Improve continuation and completion rates for mature students to 95% (full-time) and 90% (part-time); and
- 4. Raise attainment of first or upper-second class degrees for students who have a disability to 75%.

These goals reflect the College's commitment to inclusive education and long-term student success.

What we are doing to achieve our aims

We are implementing three main intervention strategies to support achievement of our targets:

- 1. Access to Cliff, including outreach and recruitment activities:
 - Storytelling campaigns ('Cliff Experience')
 - School and youth event engagement
 - Subsidised gap year and level 4 'Foundations' units
 - Financial support and staff training
- 2. Success in Learning, including activities that support student retention and achievement:
 - Study skills resources and personal tutors
 - Mental health and wellbeing support
 - Tools to track academic engagement
 - Community activities
- 3. **Positive Progression**, including activities that enhance outcomes for students with disabilities:
 - Personalised support plans and inclusive teaching and assessment strategies
 - Vocational placements and career guidance
 - Accessibility audits and improvements
 - Targeted financial support

These intervention strategies are designed to benefit all students, with a focus on those most at risk of disadvantage.

How students can get involved

We take a whole-provider approach, involving all staff and students in fostering an inclusive and supportive learning environment. Students play a key role in shaping and evaluating our access and participation plan:

- Students contribute to storytelling, feedback, and programme reviews.
- Annual reports on progress are shared with students and published online.

Evaluation – how we will measure what we have achieved

We use a robust evaluation framework to track progress, including:

- Internal data analysis, reported to relevant academic committees.
- An annual schedule of monitoring and scrutiny by oversight and governance committees.
- External discussion with our validating partner, the University of Manchester.

Evaluation findings are shared with students via the virtual learning environment (CliffX) and published annually on a dedicated access and participation plan section of the College website.
